Companies insights

Opportunities 💉

Share knowledge & costs

A recurring subject is the opportunity to learn from others. If everyone is playing the game, companies can have a view on the actual impact of some projects and be motivated to take action. In addition, shared investments are economically preferable.

Uncover unknowns

Most of the interviewees struggle to get the right information about subsidies, legislation and the market in general. They would benefit from an expert's insights to show they the right direction.

Better partnerships

Findings the right (local) partners and collaborate is a struggle for many. With a system of trusted partners which are validated from the community, we might ease that pain.

Create awareness

Most firms also struggle to imply employees in the process, the shared platform can help them to visualize energy in a more concrete way.

No dedicated FTEs

As the CEOs and directors are often in charge and lack the expertise, they would benefit from a supporting tool to take the right decisions.

A new competitive advantage

By having the right data and insights, a company might access subsidies, accreditations and financing more easily. In addition, these claims can be an important decision factors to meet the company's clients' standards.

Support decision making

Current energy decisions are not enough fact-based and are difficult to take. By demonstrating concrete cost vs impact analysis and useful reporting, the tool might make the decision makers' job easier.

Meet sustainability goals

Better insights makes it possible to report on individual and community goals.

Companies Insights



Lack of data

Most companies are not "smart" yet and thus, the available data is limited to the energy suppliers'.

Cost saving insights

Companies are aware of the opportunity to save on costs but they need a clear overview on what is feasible to be able to take decisions.

Commitment

The advantages of a community platform are clear to all but it heavily depends on each members' commitment to share data and participate actively.

No dedicated FTEs

In addition, the lack of FTEs means that time is limited and that the knowledge is often spread across the company, which might limit implementation. These companies expect a lot of input from the park manager at the very start of the process.

Efficiency

Projects are already slow enough. The fact that more companies are involved might give the impression to slower the process even more.


Insights
